(57) Abstract :

Health monitoring system and a method for monitoring health-related data is disclosed. The health-related data is collected from various data sensors and stored in the health monitoring system. The health-related data is analyzed in real time over a period of time and one or more patterns from the data are identified. It is determined if the health-related data is more than a predetermined threshold value and if there is a deviation from the one or more patterns. One or more actions are suggested to user when the health-related data is more than the predetermined threshold value and when there is a deviation from the one or more patterns.
